

USO SPANGDAHLEM “NATIONAL LOVE YOUR PET DAY” CONTEST

CONTEST ENTRY PERIOD: 02/20/19 – 02/27/19

NO PURCHASE OR DONATION NECESSARY. Enter for a chance to win one(1) gift basket for your pet. Contest is open to active-duty, National Guard, and Reserve U.S. military personnel and their dependents who are stationed on Spangdahlem and age 18 or older at time of entry. One entry per person. OFFICIAL RULES

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

CONTEST ENTRY PERIOD: The USO Spangdahlem “National Love Your Pet Day” contest (“Contest”) entry period begins at 08:00:01 AM Central European Time Zone (UTC +1) on February 20, 2019 and ends at 07:59:59 AM Central European Time Zone (UTC+1) on February 27, 2019 (the “Contest Entry Period”).

ELIGIBILITY: Active-duty, National Guard, and Reserve United States military personnel and their dependents who are stationed on Spangdahlem and age 18 or older at time of entry can enter for a chance to win one(1) pet gift basket. Employees, directors, and officers of the United Service Organizations, Inc. (“USO,” the “Sponsor,” and the “Administrator”), USO affiliates, and each of their respective advertising and promotion agencies (collectively, “Sweepstakes Entities”), and their immediate family members and/or those living within the same household of each are not eligible to enter or win. Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.

HOW TO ENTER: To enter the Contest, log into your Facebook account, “like” USO Spangdahlem’s Facebook page, “like” the USO Spangdahlem Facebook page’s post about the “National Love Your Pet Day” Contest, and then post a comment underneath the post of a picture of your pet. Pictures must be appropriate for all audiences. One(1) entry per person. To qualify for the Contest, entries must be submitted within the Contest Entry Period.

CONSUMER DISCLOSURES: No purchase or donation necessary. Contest Entry Period ends at 07:59:59 AM Central European Time Zone (UTC+1) on February 27, 2019. Prizes: A total of one(1) prize will be awarded, consisting of a pet gift basket, valued at \$50. Odds of winning depend on the number of eligible entries received during the Contest Entry Period. SELECTION OF WINNERS: One(1) winner will be selected based on the most liked pet picture on Facebook from all eligible entries received during the Contest Entry Period. The selection of

winner will be conducted at 08:00:01 PM on February 27, 2019 by the Administrator, whose decisions are final and binding in all matters relating to this Contest.

Winner will be notified by Facebook message on February 28, 2019, and will be given instructions on how to claim the prize. If a potential winner does not respond to the winner notification message (winner have a one (1) week time period to claim their prize), or if said message is returned as undeliverable, or if an entrant is otherwise found to be ineligible, or if a selected winner cannot accept or participate for any reason, the potential winner will forfeit the prize and an alternate winner will be selected. The Sponsor reserves the right to modify the notification procedures in connection with the selection of an alternate winner, if any. Prizes are non-transferable and no substitution by any winner or cash equivalent is allowed. Sponsor will not replace any lost, misplaced or stolen prizes. Sponsor reserves the right to substitute a prize with one of equal or greater value at its sole discretion. Entrants assume all liability for any injury, including death or damage caused or claimed to be caused, by participation in this Contest or use or redemption of any prize. This Contest shall be governed by and interpreted under the laws of the District of Columbia, U.S.A., without giving effect to its conflict of laws provisions. Entrants hereby agree that any and all disputes, claims, causes of action, or controversies (collectively, "Claims") arising out of or in connection with this Contest shall be resolved, upon the election by entrant or Sponsor, by arbitration pursuant to this provision and the code of procedures of either the National Arbitration Forum ("NAF") or the American Arbitration Association ("AAA"), as selected by the entrant. FURTHER, NEITHER SPONSOR NOR ENTRANT WILL HAVE THE RIGHT TO PARTICIPATE IN A REPRESENTATIVE CAPACITY ON BEHALF OF THE GENERAL PUBLIC OR OTHER PERSONS SIMILARLY SITUATED, OR AS A MEMBER OF ANY CLASS OF CLAIMANTS PERTAINING TO ANY CLAIM SUBJECT TO ARBITRATION. EXCEPT AS SET FORTH BELOW, THE ARBITRATOR'S DECISION WILL BE FINAL AND BINDING. NOTE THAT OTHER RIGHTS THAT ENTRANT WOULD HAVE IF ENTRANT WENT TO COURT ALSO MAY NOT BE AVAILABLE IN ARBITRATION. The arbitrator's authority to resolve Claims is limited to Claims between Sponsor and entrant alone, and the arbitrator's authority to make awards is limited to awards to Sponsor and entrant alone. Entry materials/data that have been tampered with or altered, or mass entries or entries generated by a script, macro or use of automated devices are void. Sponsor may also provide the personal information you provide to enter this Contest to the Contest Administrator and third-party fulfillment companies so that such companies may process and deliver prizes to winner.
